OPEN TO ALL MEMBERS

LEGISLATIVE/RPAC COMMITTEE

Monitor municipal, state, and national legislation affecting the real estate industry and promote awareness to membership. Supports Call-To-Action from National Association of REALTORS®. Develop programs and projects to reinforce REALTOR® awareness and respect for developing a cooperative spirit with government issues. Meets quarterly or as needed.

REALTOR® PROTECTION COMMITTEE

This committee is focused primarily on the protection of all REALTORS® and how to educate REALTORS® on safety. Meets quarterly or as needed.

EDUCATION COMMITTEE

Promote and organize continuing education offerings and educational seminars. Conduct annual Code of Ethics course. Promote awareness of Fair Housing Practices to members and the public. Meets monthly.

POLICIES, PROCEDURES & BYLAWS COMMITTEE

Review Bylaws and contracts for clarity, enforceability, practicality, and conformity with NAR standards. Meets as needed.

SUNSHINE COMMITTEE

Reports any personal information regarding membership such as births, deaths, weddings, and illnesses. Meets as needed.

MEMBERSHIP COMMITTEE

The Membership Committee focuses on giving back to the SOBR membership. They review applications for membership advancement and membership assistance. Meet as needed.

BANQUET / ENTERTAINMENT COMMITTEE

Help select speakers and plan the annual banquet in December. Meets as needed.

PUBLIC RELATIONS COMMITTEE

This committee, also known as the Outreach Committee, reviews opportunities for community involvement. Meets monthly.

OTHER COMMITTEES

BUDGET/FINANCE COMMITTEE

This committee shall be chaired by the current SOBR Treasurer. Other members shall include the SOBR President and President Elect.

Review financial statements, recommend expenditures, review and modify annual budget, review and discuss annual audit, and recommend policies regarding financial matters as needed.

Meets quarterly or as needed.

PERSONNEL COMMITTEE

Comprised of the Past President, President, President Elect, Secretary, Treasurer and State Director. They are responsible for supervising the hiring of the Association Executive and conducting the review of the AE.

They are responsible for creating and reviewing the Crisis Policy and Creating and/or reviewing the Board's Strategic Plan.

Meets quarterly.

NOMINATING COMMITTEE

Comprised of the President Elect as Chairman and (5) additional members. They are responsible for identifying and nominating qualified members for Board of Directors positions. The committee meets as needed.

SPIRIT/ROYR COMMITTEE

This committee is responsible for determining award recipients for the Spirit Award and the REALTOR® of the Year Award. This committee typically consists of past recipients of ROYR.
